Proposed Sugarcane Plantation in the Lower Tana River Wetlands

We are deeply concerned by the decision of the Kenya Government through the National Environment Management Authority (NEMA), housed by your ministry, to approve the development of a sugarcane plantation in the Lower Tana River wetlands. Since Kenya is a member country of Wetlands International and Contracting Party to the Ramsar Convention on Wetlands, we feel it our responsibility to draw your attention to the fact that this development is attract strong international criticism since it fails to meet basic sustainability criteria. We ask you to reconsider this decision and offer our support to define alternative sustainable development opportunities that are compatible with your commitments for the conservation of wetlands of international importance.

The planned sugarcane plantation would replace a nationally and globally valued wetland ecosystem, that is rich in biological and cultural diversity and supports the livelihoods of local communities, including small scale farmers, fishermen and pastoralists, Wetlands of this kind are the most highly threatened ecosystems in the world – and yet they have the highest value for nature and people. These wetlands are recognised to support a unique assembly of wildlife including globally significant populations of twenty-two species of waterbirds. The wetlands provide crucial stopover sites for migratory waterbirds that annually migrate to and from as far as Eurasia. Therefore, apart from the local consequences, conversion and destruction of these wetlands would result in impacts that are significant for Africa and other regions of the world.

It seems likely that conversion of the wetlands for ethanol production in the lower Tana would reduce the economic and environmental security of its peoples. Our report 'Biofuels in Africa' (May, 2008) indicates that most biofuel production schemes in Africa offer few real livelihood opportunities to local smallholders. We therefore urge you to review the full socio-economic consequences of the planned ethanol production development and to bring into consideration the socio-economic goods and services provided by the wetlands. In this context, we would like to remind you that while the EU is promoting the use of biofuels; the proposed EU policy is to exclude biofuel production from all wetland areas and areas with high biodiversity.

With this brief letter we urge you to look critically into the decision by your department, with a view to rescinding the decision, taking into account the range of environmental and socio-economic consequences and your commitments made towards sustainable development. We are at your disposal to offer technical advice and participate in all processes geared towards alternative sustainable development options, linked with the conservation of the Tana's rich natural resources.
